

The Contribution of the Hotel Sector To the Greek Economy







This study examines the contribution of the hotel sector to the economy, focusing on:

- Intersectoral linkages with other industries
- The sector's contribution to Gross Domestic Product (GDP) and Employment
- > The sector's **impact on the external balance**
- > The sector's role in generating income in other industries

- ✓ Every €1 spent on hotel services generates a total output of €1.55 in the Greek economy.
- ✓ Every €1 million spent on hotel services creates approximately 29.8 full-time jobs in the Greek economy.
- ✓ Every €1 spent on hotel services increases total imports by €0.16.



These findings highlight the fact that the **hotel sector is a key industry** of the Greek Economy.






Intersectoral Linkages of the Hotel Sector

- Approximately 35% of product increase generated by the hotel sector is distributed to other industries in the economy.
- Approximately 27% of employment increase resulting from the operation of the hotel sector is diffused to other industries.






Top 5 Industries Benefiting from the Hotel Sector (In Terms of Production)



Linkages with the Agri-Food Sector

- ✓ 74% of the total Food & Beverage (F&B) expenditure in hotels is spent GREEK PRODUCTS.
- ✓ 28% of this expenditure is directed towards local producers.




These figures highlight the **strong interconnection** between the **hotel sector** and the **agri-food industry**.





The 5 Sectors that Benefit the Most from the Hotel Industry (in Terms of **Employment**)

For every €1 million generated by the hotel industry, a total of approximately 30 fulltime jobs (direct and indirect) are created in the Greek economy.







Connection with the Local Community

- 87% of Greek hotels trust and employ workers from the local community.
- 65% of the total workforce in Greek hotels comes from the local community.

 ✓ The contribution of the hotel sector to GDP and Employment has surpassed pre-COVID-19 levels.





Contribution of the Hotel Sector to the External Sector

Additionally, due to

- the outward orientation of the hotel sector (with over 70% of hotel guests being foreign residents) and
- ✓ its low dependence on imported inputs.
 - The hotel sector significantly contributes to improving Greece's external balance



Every **€1 billion** in hotel sector revenues leads to an improvement of approximately **€552 million** in the goods and services balance of the Greek economy.

The hotel sector significantly contributes to public revenues through the collection of indirect taxes from its operations..

For every €100 of hotel product, approximately €20 corresponds to indirect taxes nearly double that of other sectors in the Greek economy.







The **HOTEL SECTOR** is a **key-sector** and is among the sectors with the **greatest economic significance** in the **GREEK ECONOMY**.

Due to the sector's outward orientation towards international markets and its low dependence on imports, the hotel industry makes a particularly **positive contribution to the external balance of the Greek economy**.

Due to its strong intersectoral linkages, the **GREEK HOTEL INDUSTRY supports income** generation and job creation across other sectors of the Greek economy.

The hotel sector significantly contributes to public revenues through indirect taxes on hotel services.
